RESOLVED, By the American Legion Department of Texas Executive Committee in a Special electronic meeting held beginning this 27th day of April 2020 at 9 a.m. and concluding on this 30th day of April 2020 at 9 a.m.; That due to the uncertainty of the duration of the disease known as Coronavirus (COVID-19), the numerous government regulations being enforced to contain it and concern for the safety of all members of The American Legion Family, the Department Executive Committee agrees that present circumstances constitute sufficient reasons to cancel the 2020 Department of Texas annual convention and elections and that all Department officers shall continue in their offices for an additional term unless replaced in accordance with the Constitution and By-Laws of the District, Division or Department, as appropriate; and be it further

RESOLVED, That all current department commission and/or committee chairman and members continue serving in their current position until they resign or are either reassigned or replaced in accordance with the Department Constitution and By-Laws at the 2020 Fall Department Executive Committee Meeting scheduled in Austin, Texas, on September 24 – 27, 2020; and, be it further
